1.1 Users

As an end-user, you can expect the following new features.

1.1.1 Merge different document types into a single PDF

With the latest release, you can now merge not only PDF files but also common Office file formats such as Word, Excel, PowerPoint, as well as image files and other document types into a single PDF document.

Additionally, it is now possible to save individual documents directly as a PDF within the dossier.

1.1.2 Word documents for minutes and decisions prefixed with agenda item name

To better distinguish between different minutes and decision documents in the meeting dossier, these documents are now automatically prefixed with the name of the corresponding agenda item in the agenda view of the meeting management.

2.1 Users

As an end-user, you can expect the following new features.

2.1.1 Create proposals directly from a GEVER dossier

Proposals for Fabasoft Boards can now be created directly from a OneGov GEVER dossier. An existing document from the dossier can be selected and transferred as a proposal document.

2.1.2 Copy documents of an agenda item back to the original location

For documents that are created as part of an agenda item in Fabasoft Boards, it is now possible to copy them back to the original location of the original proposal document (Dossier). This ensures that all relevant documents are available again in their original context.

2.1.3 Optimized display to improve performance

To improve performance when displaying large amounts of data, the display within folder items has been revised:

- **Folder items, dossiers and documents are now displayed in their own tabs**
This means that content loads faster and the overview is improved - especially when there is a lot of data.

- **The drag & drop zone in the dossier dashboard has been removed**
But don't worry: you can still drag and drop documents or subdossiers directly into the structure as usual.

3.1 Users

As an end-user, you can expect the following new features.

3.1.1 Digital signing with SwissSign

You can now also use SwissSign for your digital signature. This allows you to sign documents with legal validity in Switzerland.

3.1.2 Play videos directly in OneGov GEVER

With the latest release, you can play videos directly in the preview view without having to download them first.

3.1.3 Merging multiple PDF documents

You can now merge several PDF documents into a single PDF directly in OneGov GEVER. This eliminates the need to use external applications.

3.2 Administratoren

As an administrator, you can expect the following new features.

3.2.1 Delete canceled dossier (automatically delete the sub-objects)

With the latest release, you can automatically remove all objects contained in a canceled dossier when you delete it.

4.1 Administratoren

As an administrator, you can expect the following new features.

4.1.1 Assign separate dossier permissions

Dossier admins and responsible persons can now directly extend or withdraw permissions on a dossier. This function makes it possible to grant specific people access to a dossier, even if they do not have access to the higher-level fileplan entry. This allows you to retain control and manage access rights efficiently.

5.1.1 Download Action at Dossier and Subdossier Level

It is now possible to download individual dossiers and subdossiers.

6.1 Administrators

As an administrator, you can expect the following new features.

6.1.1 Position Numbering in Accordance with "Group-by-three"

With the September 2024 release, OneGov GEVER now supports position numbering according to the "Group-by-three" method. When importing a new filing system, you must select the numbering method.

6.1.1.1 Interruption of Numbering

In the new Group-by-three numbering, the tens structure can be interrupted, allowing for hundreds or thousands groupings. When this occurs, the interruption is indicated in the file reference by a hyphen (-).

6.1.2 Additional Component

With additional components, dossiers can be structured consistently across the entire filing system based on criteria such as customers, products, tasks, etc. This structuring allows information to be found not only in the context of tasks but also by consolidating data, for example, on specific customers, products, or tasks.

7.1 Users

As an end-user, you can expect the following new features.

7.1.1 Document Tab at Organizational System Level

Through a new tile or document tab, users can see what documents are in the current branch at each organizational position.

8.1 Users

As an end-user, you can expect the following new features.

8.1.1 Search for Involvements

Users can now add an additional column in the dossier listing to filter by involvements and roles. The search in the tools section now allows users to search for involvements and roles as well.

8.1.2 Lifecycle and Classification Fields

The value ranges for lifecycle and classification fields defined at the classification system level can now be used at the dossier level.

8.1.3 Set End Date upon Dossier Closure

When a dossier is closed, the correct end date is now adopted:

- If a valid end date is already entered in the dossier (younger than the most recently modified document), this date will be set as the end date.
- If no date is entered, the date of the most recently modified document will be set as the end date.

8.2 Administrators

As an administrator, you can expect the following new features.

8.2.1 Lifecycle and Classification Fields

At the classification system level or directly during the import of a classification system, value ranges for the lifecycle and classification fields can be defined. These values are inherited by default down to the dossier level.
